**Ticket Order Quantities:**

**The Parks and Recreation Agency agrees to:**

1. **Return all unused tickets by September 8, 2010 or accept full responsibility for payment of unused tickets.**
2. **.Tickets with missing stubs cannot be refunded.**
4. Sell tickets only as part of a parks and recreation program, keeping written records.
5. Adhere to all policies and rules which Lake Compounce has promulgated for safe operation of the Park. Some rides are restricted by height and size. No person shall bring Alcoholic beverages into the Park. No outside catering service or bulk food and beverage may be brought into the Park. No picnic baskets or coolers will be permitted inside the Park.

**CRPA will provide:**

1. Promotional materials, including posters and background information on Lake Compounce.
2. Ticket delivery in a timely manner.
3. Telephone support to assist with your orders and planning needs.

**Note: Ticket sales may begin when you receive the tickets. All unused tickets must be returned by September 8, 2010. THIS IS A FIRM DATE. No tickets will be accepted after that date, and no refunds will be issued for any tickets returned after that date. These tickets should be treated like cash. You are responsible for any tickets purchased until they are returned to the CRPA office. CRPA recommends any mailing be via certified or express mail.**

**Note:** Although these tickets apply to all normal days and hours of operation for Lake Compounce, to avoid disappointment due to weather or an unusual situation, you and your customers are urged to call ahead to confirm days and hours for your visit. No refunds will be given once tickets have been used. Unused tickets must be returned to CRPA no later than **September 8, 2010 (FIRM)** for a refund.
